# Update on all litigations between a litigant shareholder and Fondul Proprietatea SA (the "Fund")

Franklin Templeton Investment Management Ltd. United Kingdom Bucharest Branch ("FTIML / the Fund Manager"), in its capacity as sole administrator and fund manager of the Fund, would like to update shareholders and investors on all ongoing cases between a minority shareholder, loana Sfiraiala (the "Litigant") and the Fund, as set out in the table attached as an Annex to this report.

In particular, the Fund Manager would like to inform shareholders that during the last week the Court has ruled in favour of the Fund in three files, namely:

- file no. 46752/3/2012 regarding the request of intervention filed by the Litigant for blocking the registration of EGM Resolution no. 15/23 November 2012 regarding the ratification of EGM Resolutions, by rejecting the Litigant's appeal; the Court also awarded to the Fund reimbursement of litigation expenses in amount of RON 18,689.25.
