Important events to be reported:

Representation Changes at the Management Level of Franklin Templeton International Services S.À R.L. Bucharest Branch and Fondul Proprietatea S.A. effective 1 July 2025

Franklin Templeton International Services S.À R.L., in its capacity as Alternative Investment Fund Manager and Sole Director ("*FTIS / AIFM / Fund Manager*") of Fondul Proprietatea S.A. ("*the Fund*"), announces the legal representation changes at both the Fund Manager's and of the Fund's level effective 1 July 2025, as follows:

- At the level of Franklin Templeton International Services S.à r.l. Bucharest Branch, Mr. Marius Dan will replace Mr. Johan Meyer as Branch Manager of FTIS Bucharest Branch;
- At the level of Fondul Proprietatea, Mr. Daniel Naftali and Mr. Călin Meteş will
 take on the role of Portfolio Managers of the Fund. Mr. Daniel Naftali will replace
 Mr. Johan Meyer as Permanent Representative for the Fund, while Mr. Călin
 Meteş will be appointed as Substitute of the Permanent Representative.

Effective with the same date, *i.e.* 1 July 2025, Mr. Johan Meyer, CEO of FTIS Bucharest Branch and Permanent Representative of the Fund will step down from his management responsibilities related to FTIS Bucharest Branch and Fondul Proprietatea following his decision to leave Franklin Templeton after 21 years of service.

The Fund Manager will initiate the procedure for registering the said changes with the Bucharest Trade Registry.
